Adult Literacy Programs in Suffolk County (E) (F)

Adult literacy programs assist adults:

- to become literate and obtain the knowledge and skills necessary for employment and self-sufficiency;
- who are parents/guardians to obtain the educational skills necessary to become full partners in the educational development of their children;
- to obtain a secondary school credential.

English to Speakers of Other Languages (ESOL)

Provides instruction in listening, reading, oral and written communication, computer skills, and life skills for individuals with limited English proficiency.

Literacy Zones:

The Literacy Zone is a reform initiative to close the achievement gap in communities of concentrated poverty and high concentrations of families and individuals with limited literacy or English language proficiency. Literacy Zones provide a systemic approach to meeting the literacy needs of these communities characterized by significant poverty and deficits in literacy and English language proficiency. Each Literacy Zone can provide pathways out of poverty for individuals and families, in the following areas:

- A continuum of literacy from early childhood through adult, including strong support for parents' involvement in their children's literacy development at home and engagement with the school system.
- Assistance and support for out-of-school youth to enable them to complete high school and succeed in postsecondary education or advanced training.
- Postsecondary transition that enable out-of-school youth and adults to obtain a high school equivalency diploma and succeed in postsecondary education.
- Support services that enable out-of-school youth and adults who are receiving public assistance, or families with incomes of less than 200 percent of poverty, to obtain and retain employment.
- Transition programs for youth and adults returning to the community from incarceration.
- Pathways to citizenship and English language proficiency for limited English language adults.

- Workforce development programs, including apprenticeship, career and technical education, and career pathways.
- Support for mature workers and senior citizens to enable them to stay out of poverty.
- Support for individuals with disabilities and their families
- Transition support for returning veterans and their families, including disabled veterans.

A continuum of literacy services from early childhood through adult, including strong support for Pathways out of poverty are tailored to meet the needs of individuals and families located within the Literacy Zone community.

According to New York State Regulations, a child who is a United States citizen, or who is lawfully residing in the United States, is entitled to receive any social services for which the child is otherwise eligible, regardless of the residency status of the child's parent(s) or custodial relative(s). A child who is not lawfully residing in the United States is entitled to receive information and referral services, child protective services, and foster care services. Under these guidelines, Suffolk Department of Social Services (DSS) also provides voluntary preventive services to eligible children and their families. Preventive services are supportive and rehabilitative services that are provided to children and their families for:

- Averting an impairment or disruption of a family which will or could result in the placement of a child in foster care;
- Enabling a child who has been placed in foster care to return to his family at an earlier time than would otherwise be possible; or
- Reducing the likelihood that a child who has been discharged from foster care would return to such care.

Preventive services are designed to improve the well-being of the family and the safety and security of the children in those families. DSS caseworkers meet regularly with preventive service families to provide casework counseling and a wide range of supportive services either directly or through community-based agencies. The services are designed to avert disruption of a family, expedite permanency plans, reduce the likelihood that a child discharged from foster care will return into care, and support family and community reintegration following a child's return home.

All service are free of charge. Staff includes advocates who are fluent in Spanish. Interpreter services may be accessed in other languages as needed.

- Public Benefits: Information for Nassau and Suffolk County residents regarding eligibility for Department of Social Services (DSS) programs such as SNAP (food stamps), Medicaid, Temporary Assistance, emergency housing, emergency financial assistance and child care subsidies. Health Insurance Coverage for Children

In New York State, children under the age of 19 may be eligible for public health insurance coverage through a program called Child Health Plus regardless of immigration status. Eligibility is based on gross family income.

HOW TO ENROLL:

Homeless Assistance (F)

Homeless shelters and the Suffolk County Department of Social Services (SCDSS) are legally prohibited from sheltering homeless people who are undocumented. However, under a New York State regulation known as Code Blue (18 NYCRR § 304.1) SCDSS must provide shelter for <u>all</u> individuals when the temperature falls below 32°F with wind chill for at least two consecutive hours. This would include any families or individuals who are undocumented immigrants. To access SCDSS emergency services an undocumented individual/family would either report to the nearest SCDSS center or call the SCDSS Emergency Shelter assistance number after 4:30PM at 631-854-9100.
