3 **CHAIRMAN DONNELLY:**

4 Good morning and welcome to this November 12th, 2020 meeting of the
5 Suffolk County Legislature's Public Safety Committee. I'd ask you
6 to all please rise for a salute to our flag led by Legislator Rudy
7 Sunderman.

8
9 ***Salutation***

10
11 Please remain standing for a moment of silence in honor of all
12 those First Responders on duty throughout our nation. We ask for
13 the continued healing of our nation. And as always, please keep in
14 your thoughts the brave men and women serving in our Armed Forces,
15 both here and abroad.

16
17 ***Moment of Silence Observed***

18
19 Thank you. Be seated.

20
21 So, good morning. Once again, welcome to this November 12th
22 meeting of the Suffolk County Legislature's Public Safety
23 Committee. Pursuant to the Governor's Executive Order, we do not
24 have in-person comments, although comments are permitted for this
25 meeting. Comments may be provided through a three-minute phone
26 message to 631-853-3685, or via e-mail to
27 *clerk.legislature@suffolkcountyny.gov*.

28
29 So, as far as our agenda goes this morning, we do have another full
30 agenda in our Public Safety Committee. We're going to start with
31 ***Appointments*** and it's going to be ***Resolution No. 1824(-20)*** and
32 ***that's Confirming the appointment of Ms. Odette R. Hall, M.D. as***
33 ***the Chief Medical Examiner of Suffolk County (County Executive)***.
34 I'm going to allow Ms. Hall to come up for a few minutes and give
35 us a little bio and background of herself as she awaits
36 confirmation of this appointment.

37
38 **LEG. TROTТА:**

39 If I may, Chairman; a point of personal preference?

40
41 **CHAIRMAN DONNELLY:**

42 Who is that speaking?

43
44 **LEG. TROTТА:**

45 Trotta.

46
47 **CHAIRMAN DONNELLY:**

48 Legislator Trotta, I'd like to do the appointment first, as I
49 already called her up, and then we'll get to you.

50
51 **LEG. TROTТА:**

52 Thank you.

53
54 **CHAIRMAN DONNELLY:**

55 Good morning, Ms. Hall. If you could just take a few minutes to
56 give your background, your position currently within the Medical

1 Examiner's Office.

2
3 **DR. HALL:**

4 Good morning. I am a native of New York City, originally from
5 Queens. I received my Bachelor of Science Degree from Spellman
6 College in Atlanta, Georgia; I completed my Doctor of Medicine
7 Degree at SUNY Downstate in Brooklyn; I completed four years of
8 pathology training and anatomic pathology and clinical pathology at
9 the University of California in Irvine; one year of pediatric
10 pathology training at St. Christopher's Hospital for Children in
11 Philadelphia; one year of forensic pathology training at the Office
12 of the Chief Medical Examiner of the City of New York; and one
13 additional year of selective forensic cardiac pathology and
14 neuropathology also at the Office of the Chief Medical Examiner of
15 the City of New York.

16
17 I joined Suffolk County in 2009 out of fellowship from the City.
18 I left for one year in 2014, at which time I became a Medical
19 Examiner again in the City; returned to Suffolk County in 2015 and
20 took over the position of Deputy Chief Medical Examiner in March of
21 2019.

22
23 **CHAIRMAN DONNELLY:**

24 Thank you, Ms. Hall. A very, very impressive resume. Does anybody
25 have any questions for our Medical Examiner Appointee? No
26 questions so far, so I'm going to make a motion to approve.

27
28 **LEG. FLEMING:**

29 Second.

30
31 **LEG. BERLAND:**

32 Second.

33
34 **CHAIRMAN DONNELLY:**

35 Seconded by Legislator Berland, it looks like. Roll call.

36
37 *(*Roll Called by Mr. Dubois - Chief Deputy Clerk*)*

38
39 **CHAIRMAN DONNELLY:**

40 Yes.

41
42 **LEG. BERLAND:**

43 Absolutely yes.

44
45 **LEG. FLEMING:**

46 Yes.

48 **LEG. SUNDERMAN:**

49 Yes.

51 **D.P.O. HAHN:**

52 *(No response).*

53
54 **MR. DUBOIS:**

55 Hahn?

1 **D.P.O. HAHN:**

4 **LEG. GONZALEZ:**
5 Another absolutely yes.

7 **LEG. FLOTTERON:**
8 Yes.

11 Yes.

16 **P.O. CALARCO:**
17 Yes.

18
19 **D.P.O. HAHN:**
20 *(No response).*

21
22 **MR. DUBOIS:**
23 *Nine.*

24
25 **CHAIRMAN DONNELLY:**
26 Motion is *approved (VOTE: 9-0-0-1 - Not Present: D.P.O. Hahn).*

27
28 Thank you, Ms. Hall, for coming. We wish you the best of luck in
29 your new assignment in Suffolk County. To you and your staff,
30 thank you for your continued good work during these very difficult
31 and trying times in Suffolk County.

32
33 **DR. HALL:**
34 Thank you so very much, and I will be sure to share that with my
35 staff.

36
37 **CHAIRMAN DONNELLY:**
38 Thank you. Thank you for attending.

39
40 **DR. HALL:**
41 Thank you.

42
43 **CHAIRMAN DONNELLY:**
44 So before we get to our Tabled Resolutions, I'm going to allow a
45 point of personal privilege to Legislator Trotta and then I'm going
46 to allow a point of personal privilege to Legislator Calarco, and
47 then we're not going to hear any more points of personal
48 privileges. So, Legislator Trotta and then Legislator Calarco.

49
50 **LEG. TROTТА:**
51 Having been a police officer for 25 years, what I am about to say
52 is easy for me to say, from that point of view; but from a personal
53 point of view, it's actually a hard thing for me to say.

54
55 Regardless of your feelings about Doc Spencer, personal feelings
56 about Doc Spencer -- which mine are very positive, actually -- this

1 body has a responsibility to protect the integrity of this body and
2 the responsibility to the Suffolk County citizens. There are
3 serious, serious charges against this Legislator where cops had to
4 go in and arrest someone who had a prostitute, or alleged
5 prostitute, drugs and a handgun, having to make split-second
6 decisions whether or not to do -- to take force, possibly to use
7 force. There's no debate that he was texting a prostitute who is
8 dead, who died of an overdose, made plans to meet her in a County
9 car, carrying a gun, with drugs and a condom. He should not be
10 allowed to serve on the Public Safety Committee or any committee,
11 I'm sorry. The integrity of this body deserves -- and the citizens
12 deserve him to be removed from this and all of these.

13
14 You know, it's hard for me to say that from a friend point of view,
15 but from a Police point of view, there's no way he should be
16 sitting. It's not like, you know -- and I'm sure Legislator
17 Calarco is going to bring up Rudy Sunderman who I don't think has
18 any felony charge, it's down to not filling in a box.

19
20 **CHAIRMAN DONNELLY:**

21 Legislator Trotta, I appreciate that you wanted to make the point
22 and now I'm going to allow, as the leader of the institution, the
23 Presiding Officer to respond and then --

24
25 **LEG. TROTТА:**

26 But just -- I want to say one more thing, I want to say one more
27 thing. I cannot tell you how many times I've arrested people in
28 that exact circumstance and charged them in the Federal system with
29 a man with a hand gun with drugs, it's called a 924-C. It is
30 minimum mandatory 10-years in Federal prison and no bail.

31
32 **CHAIRMAN DONNELLY:**

33 Thank you, Legislator --

34
35 **LEG. TROTТА:**

36 That's the seriousness of what's going on.

37
38 **CHAIRMAN DONNELLY:**

39 Thank you, Rob. We appreciate your passion and your thoughts --

40
41 **LEG. TROTТА:**

42 Thank you.

43
44 **CHAIRMAN DONNELLY:**

45 -- but we have to maintain the decorum of this committee. I'm
46 going to allow the Presiding Officer to respond and then we're
47 going to move on to Tabled Resolutions. There'll be no further
48 discussion.

49
50 **LEG. TROTТА:**

51 I'm calling for him to remove from all -- for the Presiding Officer
52 to remove him from all committees.

53
54 **CHAIRMAN DONNELLY:**

55 Okay. Rob?

1 **P.O. CALARCO:**

2 Thank you, Legislator Donnelly. And I certainly understand
3 Legislator Trotta's position, and the charges that have been filed
4 against Legislator Spencer are serious. But there are felony
5 charges that have been filed, unfortunately, against two
6 Legislators in this body, and I think both of them have the right
7 to defend themselves and the right to have their opportunity in
8 court. I think they both have stated that the charges, that they
9 are -- they've both pled not guilty to those charges.

10
11 The statements that Legislator Trotta is making about the facts of
12 the case are just what he knows from reading a Newsday story,
13 which, quite honestly, is not the full facts I'm sure that
14 either that are known to the District Attorney, the Police
15 Department, as well as Legislator Spencer and his Legal Counsel.
16 They have their opportunity to have their day in court and I am not
17 going to treat one Legislator differently than another, and I think
18 everybody needs to have a little patience and allow the judicial
19 system to work its way through the process.

20
21 **CHAIRMAN DONNELLY:**

22 Thank you, Legislator Trotta.

23
24 So we're going to move on now to Tabled -- Legislator Calarco and
25 Legislator Trotta, for both your thoughts, and we're going to move
26 on now to our **Tabled Resolutions**.

27
28 So we have Tabled Resolution *No. 1753(-20 - Adopting Local Law No.*
29 *-2020), A Local Law to amend the School Bus Photo Violation*
30 *Monitoring Program to accurately reflect the adjudication of school*
31 *bus camera violations (County Executive)*. We have a motion to
32 approve from Legislator Sunderman. Second?

33
34 **LEG. FLOTTERON:**

35 Second.

36
37 **CHAIRMAN DONNELLY:**

38 Second by Legislator Flotteron, is that?

39
40 **LEG. FLOTTERON:**

41 Yes.

42
43 **CHAIRMAN DONNELLY:**

44 Roll call.

45
46 *(*Roll Called by Mr. Dubois - Chief Deputy Clerk*)*

47
48 **LEG. SUNDERMAN:**

49 Yes.

50
51 **LEG. FLOTTERON:**

52 Yes.

53
54 **CHAIRMAN DONNELLY:**

55 Yes.

1 **LEG. FLEMING:**

2 Pass.

3

4 **D.P.O. HAHN:**

5 No.

6

7 **LEG. GONZALEZ:**

8 I'm going to pass right now.

9

10 **LEG. KENNEDY:**

11 Yes.

12

13 **LEG. BERLAND:**

14 Pass.

15

16 **LEG. SPENCER:**

17 Pass.

18

19 **P.O. CALARCO:**

20 I feel like I'm missing something here? So before I vote,
21 Counsel --

22

23 **CHAIRMAN DONNELLY:**

24 Me too.

25

26 **P.O. CALARCO:**

27 -- could you just explain to me what this bill does?

28

29 **MS. SIMPSON:**

30 So this bill just fixes the issue in the school bus photo violation
31 bill that we passed earlier this year on adjudication for
32 localities. It's a separate bill from the bill that was proposed
33 by Legislator Krupski.

34

35 **P.O. CALARCO:**

36 So, when you say --

37

38 **D.P.O. HAHN:**

39 Thank you. Sorry. I'll change my --

40

41 **P.O. CALARCO:**

42 When you say that it's fixing it for localities, does that mean
43 that adjudication goes to the appropriate traffic agency if there's
44 an outside municipality that has their own traffic court, they
45 prosecute the case?

46

47 **MS. SIMPSON:**

48 Correct. After we had finished -- after we had drafted the version
49 that was passed here, before passage but after we had already
50 introduced it, there had been some changes made at the State level
51 about the adjudication for Villages, so this is correcting that
52 language.

53

54 **P.O. CALARCO:**

55 Okay. So if a ticket's issued in a village or a town that runs
56 their own traffic violations court, the ticket would be prosecuted

1 in that locality?

2

3 **MS. SIMPSON:**

4 Correct.

5

6 **P.O. CALARCO:**

7 Would the revenue stay in that locality or would the revenue go to
8 the County?

9

10 **MS. SIMPSON:**

11 The revenue is set in the --

12

13 **P.O. CALARCO:**

14 The ticket proceeds.

15

16 **MS. SIMPSON:**

17 The revenue is set in the State Statute as to how it's allocated.
18 And regardless, 90% of the revenue after administrative fees goes
19 to the County and 10% goes to the adjudicating village, but that's
20 something that's set in the State VTL and we don't have the
21 authority to change.

22

23 **P.O. CALARCO:**

24 Okay. Thank you. I'm a yes.

25

26 **D.P.O. HAHN:**

27 Yeah, you can change my vote. I'm sorry, I was thinking it was the
28 other one.

29

30 **MR. DUBOIS:**

31 Fleming.

32

33 **LEG. FLEMING:**

34 I do have a question for Counsel; okay, Tom?

35

36 **CHAIRMAN DONNELLY:**

37 Yes, of course, Legislator Fleming.

38

39 **LEG. FLEMING:**

40 Okay. This technology is so challenging sometimes. Sarah, I just
41 wanted to ask, I know there is a negotiation ongoing, I don't want
42 to talk about contract negotiations, but that does affect the
43 distribution of the revenue from the tickets. And I just -- before
44 I cast my vote, I wasn't clear on the reconciliation between this
45 bill and the ongoing negotiations. Is there any impact to that
46 aspect or any aspect of the negotiations if we were to pass this
47 bill?

48

49 **MS. SIMPSON:**

50 I don't think there would be any impact on the negotiations at the
51 State level involving the revenue distribution for the County and
52 the locality, because those are sections that are not being touched
53 by this resolution.

54

55 **LEG. FLEMING:**

56 No, but I mean -- I mean the negotiation that's happening between

1 the County and the vendor who responded to the RFP for the
2 administration of the program.

3
4 **MS. SIMPSON:**

5 This -- oh, sorry, I didn't understand your question then. This
6 resolution doesn't talk at all about funding of programs through
7 the -- for the resolution, that's Legislator Krupski's resolution
8 that talks about specific allocations on the funding. This one is
9 just correcting the language.

10
11 **LEG. FLEMING:**

12 So what was the specific change that the language had to be
13 corrected to reflect?

14
15 **MS. SIMPSON:**

16 It just needed to be -- there needed to be an addition that
17 villages and justice courts would have adjudication authority in
18 localities that have their own traffic violations in courts.

19
20 **LEG. FLEMING:**

21 Got it. Thank you for that clarification. Thank you, Chairman
22 Donnelly. I'm a yes on the motion to approve.

23
24 **MR. DUBOIS:**

25 Gonzalez?

26
27 **LEG. GONZALEZ:**

28 Yes.

29
30 **MR. DUBOIS:**

31 Berland?

32
33 **LEG. BERLAND:**

34 Mr. Chair, can I ask Counsel a question as well?

35
36 **CHAIRMAN DONNELLY:**

37 Of course, Legislator Berland; go ahead.

38
39 **LEG. BERLAND:**

40 Thank you. So, assuming that the creating of the ticket if someone
41 passes a school bus is from the County's program, that -- so the
42 State legislation sets this aside and says to localities you can --
43 if you have your own local traffic court, you can process this
44 County violation, it doesn't have to go before the County?

45
46 **MS. SIMPSON:**

47 Correct.

48
49 **LEG. BERLAND:**

50 Is that what the change is?

51
52 **MS. SIMPSON:**

53 Yes.

54
55 **LEG. BERLAND:**

56 All right. So even though they're prosecuting that, the State law

1 says it's a 90/10 split and --

2

3 **MS. SIMPSON:**

4 Yep.

5

6 **LEG. BERLAND:**

7 -- they're only getting 10%. Okay. All right, just wanted to make
8 sure I heard that right. All right, thank you.

9

10 **MS. SIMPSON:**

11 No problem.

12

13 **MR. DUBOIS:**

14 Legislator Berland, your vote?

15

16 **LEG. BERLAND:**

17 Yes, I'm a yes. Thank you.

18

19 **LEG. SPENCER:**

20 Yes.

21

22 **MR. DUBOIS:**

23 Ten.

24

25 **CHAIRMAN DONNELLY:**

26 Thank you, Mr. Clerk. *(Approved 10-0-0-0).*

27

28 Tabled Resolution No. *1767(-20) - Adopting Local Law No. -2020),*
29 *A Local Law to prevent reckless biking in Suffolk County*
30 *(Sunderman).*

31

32 **LEG. SUNDERMAN:**

33 I'm going to make a motion to table.

34

35 **CHAIRMAN DONNELLY:**

36 Motion to table by Legislator Sunderman.

37

38 **LEG. FLEMING:**

39 I'll second.

40

41 **CHAIRMAN DONNELLY:**

42 Seconded by Legislator Fleming. Roll call.

43

44 *(*Roll Called by Mr. Dubois - Chief Deputy Clerk*)*

45

46 **LEG. SUNDERMAN:**

47 Yes.

48

49 **LEG. FLEMING:**

50 Yes.

51

52 **CHAIRMAN DONNELLY:**

27 On Resolution No. 1767, Legislator Sunderman, you'd like the floor?

28

30 Yeah, I believe we should be able to come out next cycle, we just
31 have one more fix. We're meeting with one more group that we have
32 to talk about.

33

34 CHAIRMAN DONNELLY:

35 Thank you, Legislator Sunderman.

36

37 We'll go to ***Introductory Resolutions*** now, starting with
38 ***Introductory Resolution 1781(-20) - Directing the Suffolk County***
39 ***Police Department and the Suffolk County Community College to study***

29 *Introductory Resolution No. 1782(-20) - Accepting a gift of*
30 *bicycles from Gary Teich for use by the Suffolk County Police*
31 *Department (County Executive). I'll make a motion to approve.*
32
33 **LEG. FLOTTERON:**
34 I'll second.
35
36 **LEG. GONZALEZ:**
37 Second.
38
39 **CHAIRMAN DONNELLY:**
40 Seconded by Legislator Flotteron. On the motion?
41
42 **LEG. FLOTTERON:**
43 I'd also like to cosponsor.
44
45 **CHAIRMAN DONNELLY:**
46 Legislator Flotteron is a cosponsor. On the motion, anybody? We
47 do have Lieutenant Calandrillo in the room, if anybody would like
48 to ask any questions. Legislator Hahn.
49
50 **D.P.O. HAHN:**
51 Yeah, I'm, you know, thrilled that our officers will be getting
52 some bicycles as a donation, that's terrific. I do just want to
53 understand how these donations come about. You know -- what we
54 don't want to have happen is that there's any appearance of
55 currying favor by folks. So, there have been a lot of donations,
56 whether it's PPE or other pandemic-related supplies that have gone,

1 you know, exclusively to the Police Department; this is a little
2 bit different but, you know, there have been a lot of donations
3 this year. And I just want to understand how we can -- or if
4 there's some sort of process by which we're making sure this is
5 kept separate somehow. I don't know if you can talk about what
6 gets done when accepting donations. You know, the transparency is
7 here because we're passing the legislation so we know what's
8 happening, but I just have that concern.

9
10 **LIEUTENANT CALANDRILLO:**

11 Okay. Gary is the owner of Lee's Auto Body located in East Islip.
12 He --

13
14 **D.P.O. HAHN:**

15 I'm not in any way questioning this individual.

16
17 **LIEUTENANT CALANDRILLO:**

18 Okay. He --

19
20 **D.P.O. HAHN:**

21 Please make that clear. You know, we just have oversight and it
22 kind of -- you know, just came up during some discussions, if that
23 could be possible. Please don't attach it to this particular bill.
24 There just have been a lot of donations this year, specifically for
25 the Police Department.

26
27 **LIEUTENANT CALANDRILLO:**

28 He reached out to us, I believe it was through Legislator Cilmi,
29 this was his idea. We did not solicit this in any way, shape or
30 form. I spoke to him, he wants to do a community program to give
31 back to the Police. He identified this need on his own. He really
32 would like at least the first few bikes to go to the 3rd Precinct
33 which is where he is located.

34
35 You know, I spoke to him about the parameters of what he wants to
36 do and then I handed it off to Legal. And we probably could have
37 done these bikes individually as pro forma resolutions, but I think
38 Legal felt it was better to do it this way through the Legislature
39 because the program is going to be ongoing and we're not sure how
40 successful he's going to be and how many bikes it's going to be.
41 So that's how this came about. There's certainly no --

42
43 **D.P.O. HAHN:**

44 It's a really good thing. When police officers are able to get out
45 of their sector cars and walk a beat or ride on a bicycle, they're
46 more accessible, they're -- you know, people really get to see
47 them, so I really appreciate the donor's intention on that level.

48
49 I'm just asking from a, you know, 30,000 foot level. One of the
50 best practices around public safety departments, crime-fighting
51 departments accepting donations in this manner and I was just --
52 you know, maybe we're not ready to answer that now, but we should
53 be thinking about it.

54
55 **CHAIRMAN DONNELLY:**

56 Thank you, Legislator Hahn. Any other questions to Lieutenant

1 Calandrillo on this subject? Legislator Trotta.

2
3 **LEG. TROTТА:**

4 Lieutenant, why is it that you brought up the fact that the Police
5 Department didn't solicit or ask for this money? Is there a law
6 preventing the Police Department from doing that?

7
8 **LIEUTENANT CALANDRILLO:**

9 Well, we -- I think it would be improper if we reached out and
10 asked for solicitation of equipment that we needed. Again, he came
11 to us with this, he has written us a letter, he expects nothing in
12 return, it's unconditional, it's something he wants to do for his
13 community.

14
15 **LEG. TROTТА:**

16 Great. So it's the policy of the Police Department not to solicit,
17 you know, funds from any private citizens.

18
19 **LIEUTENANT CALANDRILLO:**

20 That is --

21
22 **LEG. TROTТА:**

23 And that's for the integrity of the Police Department, correct?

24
25 **LIEUTENANT CALANDRILLO:**

26 Yes, sir; that is correct, sir. We actually specifically told him
27 when he raises money for this, it cannot be on behalf of the
28 Suffolk County Police Department. So he has -- he's titled the
29 program *Bike The Blue*, and it's a very generalized program and it's
30 basically just raising money for Police bikes. He is not to
31 solicit on behalf of the Police Department, Suffolk County Police
32 Department.

33
34 **LEG. TROTТА:**

35 Thank you very much. It's a good law to have in effect. Thank
36 you.

37
38 **CHAIRMAN DONNELLY:**

39 Thank you, Legislator Trotta. Legislator Krupski.

40
41 **LEG. KRUPSKI:**

42 Thank you. Does this individual do any business with the County?

43
44 **LIEUTENANT CALANDRILLO:**

45 Not that I'm aware of.

46
47 **LEG. KRUPSKI:**

48 Okay. Thank you.

49
50 **CHAIRMAN DONNELLY:**

51 Thank you, Legislator Krupski. Legislator Flotteron.

52
53 **LEG. FLOTTERON:**

54 Yes, I'll just let everybody know. This is a project that
55 Legislator Cilmi and myself have been working on. I've done even
56 historically many -- millions of dollars' worth of projects working

1 with the private sector. This one is, again, a very generous
2 person in the East Islip -- actually, the East Islip Chamber
3 President. He has worked with children with disabilities to
4 refurbish cars, security cars for the local East Islip School
5 District; they're doing always outreach stuff, that's just the type
6 of person this person is. Even during the pandemic, you know, he
7 thought it was wonderful when he saw the Police walking the beats
8 in the downtowns, which we did I think after the last class
9 graduated, I guess the Police Department was matching up the new --
10 the newly-trained officers. And it was more like, *Hey, how can we*
11 *keep them more in our downtowns.* Again, he's done programs with
12 veterans where he took a car, got it rebuilt by Children with
13 Disabilities and it brings the veterans to the doctor's offices.

14
15 So this is more just a very giving person who likes to bring the
16 community together to help everyone, and right now he thought it
17 would be great to help our men in blue that we all stand with them
18 in this community and what they do here and that's all this is. In
19 the long run, it saves the taxpayers money. We don't have to bond
20 out to buy bicycles, which is great. So, that's why I want to
21 cosponsor this also.

22
23 **CHAIRMAN DONNELLY:**

24 Thank you, Legislator Flotteron. Legislator Gonzalez.

25
26 **LEG. GONZALEZ:**

27 Yeah, I'm just dittoing what Legislator Hahn is saying. I don't
28 think there's anything personal with the individual, but at the
29 same time we just want to be very, very, very careful going
30 forward.

31
32 Legislator Flotteron, again, it's nothing personal, because I think
33 I was one of the ones that was asking the particular question.
34 It's just that, you know, we just want to make sure that the
35 integrity of the cause is proper. It's going through the right --
36 you know, going through the right way and we're not saying --
37 again, I'm not saying that. And I know the individual, I know the
38 company, but, you know, as we go forward history has shown us that
39 regardless of the individual's work in the community, there is
40 always that possibility. And as Legislators, we have to look at
41 every angle to make sure that there's nothing, nothing moving
42 forward that is going to hurt or make us look all really stupid or
43 bad.

44
45 So, listen, I'm with this. We just -- you know, we're just trying
46 to be very, very careful. And listening to Lieutenant Anthony
47 Calandrillo, okay, we get it, but it's just -- we're just making
48 sure that we don't get bit later. So I'm just putting in my two
49 cents exactly what Legislator Hahn is expressing. Thank you, but
50 I'm good.

51
52 **CHAIRMAN DONNELLY:**

53 Thank you, Legislator Gonzalez. Next we have Legislator
54 Piccirillo.

1 **LEG. PICCIRILLO:**

2 Thank you, Mr. Chairman. Does somebody know something that the
3 rest of us don't know, that we're debating whether we should take a
4 donation from a bicycle company, from an auto body company?
5 Because yesterday there was a bill in front of us about Legislative
6 oversight -- excuse me, on Monday -- and it was tabled. So you
7 only want Legislative oversight when you want it.

8
9 **D.P.O. HAHN:**

10 Legislative oversight?

11
12 **LEG. PICCIRILLO:**

13 I yield back.

14
15 **D.P.O. HAHN:**

16 So --

17
18 **CHAIRMAN DONNELLY:**

19 No arguing. No arguing, folks. Look, we want to be respectful,
20 we're all colleagues, everybody will get a point of personal
21 privilege to speak. But please, it's very -- I can now appreciate
22 the Presiding Officer's difficulty in trying to manage these
23 meetings. So, we're going to go back to Legislator Hahn now.

24
25 **D.P.O. HAHN:**

26 So as I said, it has nothing -- nobody knows anything, there's
27 nothing. This is a question of giving to police officers and
28 giving, you know, donations. How would you feel if somebody said,
29 *Oh, I want to give XYZ to the District Attorney.* You know, there
30 is a different responsibility when we have Detectives, when we have
31 people who crime fight. It just -- you know, there's this
32 possibility that the perception is a currying favor and it's -- you
33 have to protect both against the perception and the reality, right?

34
35 So, I hope you can understand the questioning comes as someone who
36 has oversight over this department, you know, wanting to make sure
37 we're as transparent and careful as possible not to harm the
38 reputation in any way, not to appear to be accepting things that
39 could be taken as inappropriate. And I'm not suggesting it is in
40 this case, which I made crystal clear but you chose not to hear.
41 I'm just suggesting that the practice may have the possibility of a
42 perception that we don't intend and that does not exist, you know,
43 reality that does not exist.

44
45 And that's why, you know, I'm just wondering if there's best
46 practices that police organizations around the country recommend.
47 And I don't know enough about the practices we follow, just not to
48 solicit in my mind is not enough. And, you know, I'm probably
49 going to have to now do more research into should we have, you
50 know, more checks and balances or what do other departments do,
51 what do national associations recommend in terms of accepting gifts
52 for Police Departments. That's all.

53
54 **CHAIRMAN DONNELLY:**

55 Thank you, Legislator Hahn. Legislator Flotteron, do you have your
56 hand raised? The floor is yours.

1 **LEG. FLOTTERON:**

2 Yes. And I understand what Legislator Kara Hahn has said. It's
3 just that I think the difference here, this gift is not -- when we
4 use the word *gift*, we think of things like we're buying them lunch
5 or things like that. This is just regular, hard materials, just
6 like if we got a donation for copy toner. You know, this is just
7 to do the job. This is saving all taxpayers on bonding, so it's
8 not a personal gift, you know, to a certain --

9
10 **D.P.O. HAHN:**

11 No, recognize -- I love it. I preface this with I love --

12
13 **LEG. FLOTTERON:**

14 Yeah.

15
16 **D.P.O. HAHN:**

17 We need bicycles for our officers. Again, I just --

18
19 **LEG. FLOTTERON:**

20 These are tools that we would normally --

21
22 **D.P.O. HAHN:**

23 I wanted to do our due diligence and this has been like --

24
25 **LEG. FLOTTERON:**

26 I was speaking.

27
28 **D.P.O. HAHN:**

29 -- this has been -- there have been a number of them.

30
31 **LEG. FLOTTERON:**

32 I was speaking.

33
34 **D.P.O. HAHN:**

35 Yes.

36
37 **LEG. FLOTTERON:**

38 And again, this is just a capital gift, it's not any personal gifts
39 to them. And I understand your point and I'm just saying, you
40 know, it's not like we're buying them lunch in this case. This is
41 for regular capital things like copy toner, no different. And I
42 understand your point. Maybe that's part of the separation that
43 you might want to look into, that you were saying, you know, is it
44 personally being enriched or is it just daily tools which make --
45 you know, maybe we got it a little sooner and fresher than we
46 needed, and that's what's going to happen here. So we all save,
47 right? Thank you.

48
49 **CHAIRMAN DONNELLY:**

50 Thank you, Legislator Flotteron. As the Presiding Officer would
51 say, I think we talked this one out.

52

2 Yeah, just a question for Lieutenant Calandrillo. This looks
3 like -- if we could just get a little background. Is this
4 something that's been prompted by the -- by the criminal justice
5 reforms? Is this necessary now because more people are going
6 through Probation for drug-related crimes, or -- I'm just really
7 trying to track impact and am interested to see -- obviously we
8 would want to handle substance abuse issues, you know, the most
9 efficient, effective way. So I see it moving from Health
10 Department to Probation; do you have any background on that?

11
12 **LIEUTENANT CALANDRILLO:**

13 No, Legislator, I do not. This money is going to the Department of
14 Probation; I don't think we get any other.

15
16 **LEG. FLEMING:**

17 Right. No, no, no, I just -- since there's nobody here from
18 Probation, I was hoping you might have a little background. I'm
19 fully in support, I just think it's important for us, as the
20 oversight body, to understand that we're continuing to make
21 adjustments in the budget. Probation's workload has gone up
22 significantly because so many fewer people are actually in the
23 system who are incarcerated, you know, for drug crimes.

24
25 It's a complex and super challenging circumstance for local
26 government based on what New York State Legislature and the
27 Governor did with regard to the criminal justice reform. So I just
28 think it's important, you know, at every opportunity, to get --
29 have a real understanding of the impacts, especially the fiscal
30 impacts of this. So I will myself follow-up with Probation, I was
31 just hoping you might have some information. But I appreciate it,
32 Legislator Donnelly. I'm a yes on the legislation and I'll follow
33 up with the Probation Department.

34
35 **CHAIRMAN DONNELLY:**

36 We have Commissioner Neubauer right here in the audience --

37
38 **LEG. FLEMING:**

39 Oh.

40
41 *(*Laughter*)*

42
43 **CHAIRMAN DONNELLY:**

44 -- at the horseshoe, so she will answer your questions.

45
46 **LEG. FLEMING:**

47 I'm so sorry.

48
49 **CHAIRMAN DONNELLY:**

50 Commissioner Neubauer.

51
52 **DIRECTOR NEUBAUER:**

53 Thank you. No apology necessary. If I can, by way of background.
54 The Probation Department had previously received a \$2 million grant
55 from SAMHSA. This grant was going to span five years, \$400,000 for
56 each of the five years of the grant. We completed year one of the

1 grant on September the 30th of 2020, and there were funds
2 remaining, unspent, from year one, and so we are simply
3 transferring these funds from year one to year two.

4
5 The grant was intended to expand the Judicial Diversion Program
6 which is a Drug Court Program in the Superior Court in Riverhead.
7 And because during year one we were a little bit slow in getting
8 started, there were some positions that were not filled as quickly
9 as we had anticipated, that is why really we have the unspent money
10 which we are just moving over to year two.

11
12 **LEG. FLEMING:**

13 So but it's not going from a different department from yours?

14
15 **DIRECTOR NEUBAUER:**

16 No, no, no.

17
18 **LEG. FLEMING:**

19 The title reads a little bit differently, it's transferring it from
20 the Department of Health & Human Services to the Department of
21 Probation.

22
23 **DIRECTOR NEUBAUER:**

24 Yes, it is Health & Human Services money that had been awarded to
25 us in a five-year grant. This was year one of the award which was
26 not spent in full and which SAMHSA is allowing us to transfer to
27 year two.

28
29 **LEG. FLEMING:**

30 Gotcha. Is this the -- is this the Drug Court I think I've
31 attended; there are a lot of helpers that are veterans from the
32 Vietnam War that appear and assist other veterans going through the
33 Drug Court?

34
35 **DIRECTOR NEUBAUER:**

36 I believe you're referring to the Veterans Court which is a
37 separate specialty court, not to be confused with the Judicial
38 Diversion Program.

39
40 **LEG. FLEMING:**

41 So are they only substance abuse offenders who are in this
42 courtroom?

43
44 **DIRECTOR NEUBAUER:**

45 In the Judicial Diversion Court, yes, their -- their primary
46 diagnosis would be one of a substance use disorder.

47
48 **LEG. FLEMING:**

49 And what are you seeing? I know you said it's only the second
50 year, but what are you seeing in terms of impacts of the criminal
51 justice reforms on that court? Are there impacts? Is it giving it
52 a fuller role, is it more important? Are there no impacts? Am I
53 going down a rabbit hole that's --

54
55 **DIRECTOR NEUBAUER:**

56 *(Laughter)*.

1 **LEG. FLEMING:**

2 -- that's wasting everyone's time?

3
4 **DIRECTOR NEUBAUER:**

5 Well, clearly there is a need for the specialty court involving
6 persons who have been charged with a felony offense, typically a
7 drug-related felony offense and themselves diagnosed with a
8 substance use disorder. There's no doubt in my mind that there is
9 a need for that court. And the purpose of the court is really to
10 engage people in treatment and to keep them in treatment so that
11 they get better and go on to become, you know, productive members
12 of the community. And the gain for the participant in the program
13 is perhaps a more lenient sentence or a reduction in the charge at
14 the point of conviction and sentence. And there's clearly a need
15 for the program.

16
17 I don't know that there has been any impact as a result of criminal
18 justice reform; and if you're referring to bail reform, I don't
19 know if there's been an impact and it may be too soon to know.

20
21 **LEG. FLEMING:**

22 One of the reasons why I ask is because I know in these drug
23 diversion courts, you know, when you're first arraigned you have
24 the opportunity with your lawyer to make a decision as to whether
25 you want to go into a diversion court or get it over more quickly,
26 because the diversion courts are very stringent in terms of
27 long-term -- you have to keep coming back to the Judge --

28
29 **DIRECTOR NEUBAUER:**

30 Uh-huh.

31
32 **LEG. FLEMING:**

33 -- and (audio malfunction) get you out of the world of drugs. It
34 seems like a great program, but I would think there would be
35 less -- just thinking about it, there would be less incentive for
36 someone to want to be in a diversion program if they know they're
37 just going to be released regardless. So I just wonder if these
38 criminal justice reforms might have undermined a little bit some of
39 the good work that was already being done on drug diversion.

40
41 **DIRECTOR NEUBAUER:**

42 Well, bear in mind that this is a drug diversion court in the
43 Superior part. And some of the defendants that are appearing in
44 that part have a prior felony conviction, so the stakes upon
45 conviction of a second felony are much greater than they would be
46 if that person was not a prior felony offender. So I think for a
47 lot of defendants there really is a motivation to participate in
48 the Judicial Diversion Program in the Superior Court.

49
50 **LEG. FLEMING:**

51 Yeah, I've seen it work real wonders on the Village level and Town
52 level as well, they have those courts. The great Judge Allen Smith
53 who passed away a few months ago.
