body has a responsibility to protect the integrity of this body and the responsibility to the Suffolk County citizens. There are serious, serious charges against this Legislator where cops had to go in and arrest someone who had a prostitute, or alleged prostitute, drugs and a handgun, having to make split-second decisions whether or not to do -- to take force, possibly to use force. There's no debate that he was texting a prostitute who is dead, who died of an overdose, made plans to meet her in a County car, carrying a gun, with drugs and a condom. He should not be allowed to serve on the Public Safety Committee or any committee, I'm sorry. The integrity of this body deserves -- and the citizens deserve him to be removed from this and all of these.

You know, it's hard for me to say that from a friend point of view, but from a Police point of view, there's no way he should be sitting. It's not like, you know -- and I'm sure Legislator Calarco is going to bring up Rudy Sunderman who I don't think has any felony charge, it's down to not filling in a box.

The statements that Legislator Trotta is making about the facts of the case are just what he knows from reading a Newsday story, which, quite honestly, is not the full facts I'm sure that either that are known to the District Attorney, the Police Department, as well as Legislator Spencer and his Legal Counsel. So, I hope you can understand the questioning comes as someone who has oversight over this department, you know, wanting to make sure we're as transparent and careful as possible not to harm the reputation in any way, not to appear to be accepting things that could be taken as inappropriate. And I'm not suggesting it is in this case, which I made crystal clear but you chose not to hear. I'm just suggesting that the practice may have the possibility of a perception that we don't intend and that does not exist, you know, reality that does not exist.

And that's why, you know, I'm just wondering if there's best practices that police organizations around the country recommend. And I don't know enough about the practices we follow, just not to solicit in my mind is not enough. And, you know, I'm probably going to have to now do more research into should we have, you know, more checks and balances or what do other departments do, what do national associations recommend in terms of accepting gifts for Police Departments. That's all.

grant on September the 30th of 2020, and there were funds remaining, unspent, from year one, and so we are simply transferring these funds from year one to year two.

The grant was intended to expand the Judicial Diversion Program which is a Drug Court Program in the Superior Court in Riverhead.
And because during year one we were a little bit slow in getting started, there were some positions that were not filled as quickly as we had anticipated, that is why really we have the unspent money which we are just moving over to year two.
