LOCAL EMERGENCY ORDER No. 219 EXTENDING LOCAL EMERGENCY ORDER No. 174, 179, 183, 187, 191, 195, 198, 201, 204, 207, 210, 213 and 216 UNDER § 24 OF ARTICLE 2-B OF THE EXECUTIVE LAW

Local Emergency Order:

Expanding the Authority of Suffolk County Fire Marshals

I, Steven Bellone, the Chief Executive of Suffolk County, in accordance with a Proclamation of a State of Emergency issued pursuant to Section 24 of the New York State Executive Law on March 12, 2020 and continued on April 11, 2020; May 11, 2020; June 10, 2020; July 10, 2020; August 9, 2020; September 8, 2020; October 8, 2020; November 7, 2020; December 7, 2020; and January 6, 2021 and my power thereunder to protect life and property or to bring an emergency situation under control do hereby:


Order, that due to the continuing threat to the public health, safety and welfare of Suffolk County residents and visitors posed by Covid-19 and public congregation and gatherings, Local Emergency Order Nos. 174, 179, 183, 187, 191, 195, 198, 201, 204, 207, 210, 213 and 216 are extended and the authority conferred upon Suffolk County Fire Marshals pursuant to Chapter 94 of the Suffolk County Code is expanded to include inspection of non-County owned facilities, buildings or businesses for violations and enforcement of Covid 19-related State Executive Orders, Local Emergency Orders and New York State Law and regulations; and further

Order, that in accordance with Executive Law §25 said Fire Marshals shall be utilized in such manner as I deem necessary or appropriate to cope with the ensuing disaster or any emergency resulting therefrom; and further


Order, that all Suffolk County Departments, Agencies, and Divisions or other duly authorized law enforcement agencies take whatever steps are necessary to assist in performing such emergency measures as deemed necessary.

This order shall cease to be in effect five (5) days after promulgation or upon declaration by the County Executive that the state of emergency no longer exists, whichever occurs sooner. The County Executive nevertheless, may extend such orders for additional periods not to exceed five (5) days each during the pendency of the local state of emergency. Failure to obey this order is a criminal offense, punishable by law under New York State Executive Law § 24 (5).
