Please note that Governor Kathy Hochul signed S.50001/A.40001 into law which waives Open Meetings Law requirements through January 15, 2022. Therefore, beginning with the September 27, 2021 committee cycle and continuing through the end of the year, the Legislature will be reverting to the rules of operation that were adopted via procedural motion in March of 2020.

Consequently, we will be conducting our legislative meetings in a hybrid fashion. We will allow in-person public attendance and in-person public portion comment at the William H. Rogers Legislature Building or remote testimony via Zoom. Either way, speakers will be limited to 3 minutes.

In accordance with county and state COVID-19 safety protocols and current CDC recommendations, members of the public will be required to wear a mask at all times while inside the building.
